In the event it is necessary to place a Dumpster on public property the location and use shall be included and request for such placement shall be included on this application and request for approval of such use shall be requested by the Borough. Upon granting of the permit, the Borough may place conditions on the placement and use of the Dumpster.

Dumpsters to be used exclusively for construction purposes and intended to be on site for more than sixty (60) days, either consecutive or non-consecutive, are exempt from the screening

requirements of the Ordinance conditioned upon a special grant of approval by the Glen Rock Borough Council, such approval shall be requested in writing and shall outline the use of the dumpster, the length of use, either consecutive or non-consecutive, and the site or location of the placement of the dumpster. A copy of the rental, lease or other agreement between developer and provider will be required to be submitted with such request.

All requirements of Ordinance 442 (2006-3) shall be strictly followed and **all work shall be done in full compliance with Ordinance No. 442 (2006-3) and all ordinances of the Borough of Glen Rock and the laws of the Commonwealth in relation thereto, and to well and truly save, defend and keep harmless the Borough from and indemnify it against any and all actions, suits, demands, payments, costs and charges for or by reason of the proposed opening or excavation, and all damages to persons or property resulting in any manner there from, or occurring in the prosecution of the work connected therewith or from any other matter, cause or thing relating thereto.**
