

**GLEN ROCK BOROUGH  
QUARTERLY COUNCIL MEETING  
October 30, 2019**

**The meeting was Called to Order** at 7:00PM by Council President D. Young beginning with the pledge to the flag. Items discussed by Council are as follows:

- Kevin Hale, Fire Police Captain with Glen Rock Hose & Ladder, presented a request for equipment as part of the Borough's 2020 Budget. He is willing to submit an inventory list of GR Fire Police Equipment to Council.
- A. Merrick presented Resolution 2019-22, formally appointing Samantha Cole to the Recreation Board for three-year term. R. Apgar moved to adopt Resolution 2019-22, appointing Samantha Cole to the GR Recreation Board for three-year term expiring December 31, 2022, seconded by J. Merrick. Motion carried.
- A. Merrick requested a motion to sign Hamilton & Musser, PC 2019 QuickBooks Online Consulting Service Agreement. R. Apgar moved to authorize A. Merrick to sign Hamilton & Musser, PC 2019 QuickBooks Online Consulting Service Agreement, seconded by J. Merrick. Motion carried.
- Council discussed the draft Intergovernmental Agreement for law enforcement services with Southern Regional Police Department. Several concerns with the IGA include but are not limited to municipalities that may withdraw get nothing, weighted voting gives no power to Glen Rock Borough, termination is tied to existing police union contract, PPU's are not part of the IGA, obligated police activity is not well defined, and Article V Section A takes the budget preparation away from the Chief. GR Police Commission representatives will discuss GR's concerns with the rest of the Southern Regional Police Commission.
- Council discussed installing an electric vehicle charging station in the Borough. Federal funds may be available.
- Council talked about stream clean up and maintenance. Currently the stream bank is overgrown and unkept. A plan for regular maintenance needs developed.
- Council would like to consider all options for new Community Center.
- Council discussed development of a long-term plan for indoor storage of Borough Equipment.
- Council conversed about who are the available/eligible snow plow operators and asked for possible consideration to add depth to the list, as long as individuals are properly vetted.

- A suggestion was made to develop a committee to investigate possible savings related to Water & Sewer/Borough activities.
- Council would like to offer Electronics Recycling Service to Borough residents. President D. Young will discuss with Works Supervisor.
- Council talked about Halloween and decided to keep original schedule of October 31.
- R. Apgar will investigate whether Penn DOT has Yield to Pedestrian Signs for cross walks.
- York County 911 is updating their maps. GR Borough administration will work on providing as accurate information as possible to YC 911.
